 - (d) CCEs Identification Number of this letter by which use of apparatus is approved.
- 4). A certificate to the effect that the equipment has been manufactured strictly in accordance with the drawing referred to in the CIMFR, Dhanbad Test report and is identical with the one tested and certified at CIMFR, Dhanbad shall be furnished with each equipment.

- 5). - 6). The IS/IEC 60079-17 and IS/IEC 60079-19 shall be followed for maintenance and repair of overhaul of the subject equipments.
